Sac and 1 will be planted in the back Cull De Sac.

· Speeding in the Neighborhood

Speeding in the neighborhood came up again. Those attending agreed it is those visiting in the area. Ideas were brought up; children at play signs, talking to the traffic engineer, and lowering the speed limit. Mike Nolan will talk to the traffic engineer and see what can be done.

Sewage Plant

Tommy spoke about the consolidation plans of the parish for the sewage plant. Plans are still up to 5 years in the making. It was acknowledged that if anyone smells sewage coming from the plant in the back, something is wrong and the parish needs to be called.

Construction Issues in Neighborhood

Homeowners brought it to HOA attention that the construction trucks seem to be taking the turns in the neighborhood short, which is destroying corner lots and creating dips in the road. Mike will look into it.

The neighborhood will be having the 3rd Annual Halloween Celebration. There will be a block party set up on Coquille and De Zaire streets. Hay rides and fun to be had for all. Festivities will begin at sunset.

Open Questions / Concerns from Homeowners

- Bruce thanked HOA for their commitment in completing everything this year.
- Are we planting the trees ourselves? Do we need to coordinate a team to complete this, like the sod? HOA will look at cost and let everyone know.
- Doreen wanted everyone to know the landscaper has one more year with his contract. Everyone agreed the landscaping looks great. No complaints with the work.
- Homeowners complained about pushy solicitors in the neighborhood. It
 was brought up if it is possible to put up No Solicitors Signs in front of
 neighborhood. Mike will look into it.
- Painting of the speeding signs was brought up again. HOA will get paint and will let everyone know when we will get together to completer this task.
- It was brought to the HOA's attention that there is another debris pile in the back of the subdivision. HOA will talk to landscaper to remove it or hire a company to remove it.
- Homeowners questioned if the new construction in the neighborhood is to code? Due to anticipated new flood zoning with FEMA, most of the homes will be zone X instead of zone A. The new construction is to code and will still be in unison with the other homes. Tommy assured everyone that an Elevation Certificate will probably be needed by all homeowners to give to insurance companies. Increases came be from \$350-1400 a year; however, increases can only be done in increments. Mike Nolan gave the website of Isuagcenter.com to read about the guidelines.
- Resident complained about how the HOA handled an issue with his landscaping. He stated we were unprofessional by knocking on his door and upset his wife. The HOA apologized that he was unhappy with our actions. He requested correspondence by mail from HOA until he sells his home. All agreed with this.
